Counteri Ugly Kitchen Contest Official Rules

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.
- 2. ELIGIBILITY. The "Ugly Kitchen Photo Contest" (the "Contest" or "Promotion") is open to U.S. residents who reside in Maricopa or Pinal County, Arizona who are 21 years or older and own their home at the time of entry. The "Contest Period" will begin at 12:01 a.m. (.) on October 10, 2023, and end on November 12th, 2023 and 11:59pm, inclusive of the following deadlines: A) GENERAL ENTRY VIA EMAIL: The contest will open for submissions at 12:01 a.m. (C.S.T.) on October 10, 2023 and close for entry submissions On November 12th, 2023 at 11:59 p.m.
- **4.** Contestants will be required to apply at this www.counteri.com/contest and upload pictures and the total square foot of their kitchen. Contestants must also like our Facebook page, tag three friends of our Ugly Kitchen Contest Facebook post and share the post to their personal Facebook page. Only one submission is allowed per person, per residence.

5. SELECTION OF WINNER: This contest is eligible to all persons who adhered to the official contest rules. Counteri will use software to ensure 100% random drawing.

Counteri will announce the winner of the Ugly Kitchen Contest on Wednesday, November 15, 2023. G) ANNOUNCEMENT OF WINNER: The Grand Prize Winner of the Ugly Kitchen Photo Contest will be announced via Facebook on Wednesday, November 12, 2023. The Contest computer is the official timekeeping device for the Contest.

- **6.** TO ENTER: Go to www.counteri.com/contest Complete the nomination to full completion, photos of your kitchen and dimensions are required.
- 7. ENTRY PARAMETERS. Each photo submitted must be authentic, and accurately depict the kitchen. The photos may be cropped as the submitting contestant prefers, but photos must not be digitally altered or enhanced in any way other than cropping. The photos must be taken by the entrant. The photos: (i) must be the original and sole creation of the entrant, and all right, title and interest including but not limited to the copyright and moral rights in all of the photos must be owned solely by the entrant, (ii) must not have been submitted in any other competition, (iii) must not have been published in any other medium/forum, (iv) must not infringe upon any third party's rights, including but not limited to, copyright, patent or trademarks/trade names/logos, or rights of privacy or publicity, or contain material that is or may be considered defamatory, slanderous or libelous, or portray or depict any person, product or entity in a false light, (v) must not violate any law, rule or regulation, (vi) must not contain any virus, bugs, or other deleterious material, and (vii) must not, for example, without limitation, contain, profanity, nudity, defamatory statements, words or symbols widely considered offensive to individuals of any certain race, ethnicity, religious, sexual orientation or socioeconomic groups, threats to any person, place, business, group or world peace; and each entrant warrants and represents that each of his/her photos comply with all of those conditions. - **9.** PRIZE CONDITIONS. The new custom epoxy countertop for the Ugly Kitchen contest winner, will be installed in the home by or before December 17, 2023. Prize is not

transferable.
